## TERMS AND CONDITIONS FOR USE OF CARDTROL:

1. Customer agrees to read and follow the terms and conditions as set forth below for the convenience of using the CardTrol Credit Card System.
2. Customer acknowledges proper instruction for safe use of equipment.
3. Customer agrees to accept the responsibility of attendance while equipment is dispensing product and further agrees not to dispense Class I liquids into containers that will not comply with Colorado State Fire Codes.
4. Customer agrees and understands that all purchases will be charged to their convenience charge account and will be due and payable as previously agreed to in the credit policy of the Co-op and further acknowledges that he/she is responsible for all charges made against their account by all CardTrol cards properly issued to patron on his/her behalf and is solely responsible for the use of the cards by any and all persons authorized or unauthorized.
5. In the event that any card is lost or stolen, customer agrees to immediately notify the Co-op in writing of this loss; in any event, the customer will be liable for any use of this card until written notification has been received by the Co-op.
6. In the event the customer’s account is not paid as agreed, or for other reasons unknown, the Co-op reserves the right to cancel or temporarily invalidate all customer cards until all parties can agree to the rights and obligations of this agreement.
7. Original and worn cards will be issued at no cost to you. Lost cards will be cancelled and reissued for a \$5.00 per card service charge.
8. Customer understands and agrees that all CardTrol Cards are the property of American Pride Co-op and may be used at any American Pride Co-op location with CardTrol facilities\*, and further agrees to surrender same at request of American Pride Co-op.

The signing of this agreement is acknowledgement that I have read and understand the conditions and agree to accept the responsibilities as afore described.
